In addition to this form, all new borrowers at Mount Olive College must complete a Master Promissory Note (MPN). Once MOC certifies your loan you will receive a MPN from your lender. You must complete the MPN and return it to the appropriate lender in a timely manner. Once your MPN has been processed by the lender, you will receive a disclosure notice by mail. The disclosure notice will indicate the loan amount and the scheduled disbursement date(s). You may borrow from this note each year without having to complete a new MPN as the MPN is multi-year sensitive.

\*You MUST return this Stafford Loan Information Sheet and indicate the amount you wish to borrow in number 1. The full amount of your loan eligibility is the combination of the unsubsidized and the subsidized loans listed on your official award letter. We encourage you to only borrow the amount you will need. Ultimately, this money must be repaid to the lender.

We encourage you to research the lender that best meets your needs. For your convenience, we have included information on a few lenders on a separate sheet. Even though this is not a complete list of lenders, it will give you an idea of the options you may choose from. **If you do not choose a lender we will be unable to process your loan.** For most lenders, Mount Olive College will receive the loan proceeds by electronic funds transfer (EFT). However with some lenders we will receive the loan proceeds by master check.

**NOTE: FOR FIRST TIME BORROWERS AT MOUNT OLIVE COLLEGE**

Before the Office of Financial Aid certifies your loan, we are required by Federal Regulations to conduct entrance counseling with each borrower. **There are no exceptions to this policy.** You may visit the Mount Olive College Online Entrance Counseling web page [mappingyourfuture.org](http://mappingyourfuture.org).
